Denny Norris called meeting to order at 7:56 a.m.

Denny Norris opened the meeting in prayer.

**Approval of the minutes**- Bill Moretz made a motion to accept, Todd Combs 2<sup>nd</sup>. Minutes accepted.

Approval of the agenda- Denny Norris moved Chris Hughes RC&D report to after Alan Walker – to allow him to get to Commission meeting on time. Agenda accepted.

Alan Walker, Research Institute – RI would like to partner with Watauga County Soil & Water on a stream project with EQUIP. It would consist of 4600' of the Watauga River and 8000' of Baird Creek. It would be around \$460,000 with a 60/40 split between Federal and State funding. The cooperator is Henry Reece. The Resolution would be the same as Vanderpool and RI would also need a Conflict-of-Interest form signed by the Board Chair. Chris Hughes made a motion to partner with RI and Jennifer Hanifan 2<sup>nd</sup> the Motion. Motion carried.

Mr. Walker also stated that the Vanderpool Spring Development construction to begin after the Trout moratorium in April.

RC&D Report – Chris Hughes – The RC&D has not met since our last meeting, but they did sponsor the Farm City Banquet. They are also partnering with the District on the Valle Crucis Park project.

Mr. Hughes stated that The Soil & Water Commission is meeting in Watauga County at 9:00am today for the first time.

Mr. Hughes stated that the Commission had a tour of De La Cruz farm on November 14<sup>th</sup> followed by a talk by James Wilkes, a professor at Appalachian State University about his Bee Keeping Software. The 2<sup>nd</sup> Tour after lunch will be to Joey Clawson's Christmas tree farm. Dinner will be at 4:30 at the Dan'l Boone Inn with a work session in the Watauga County Commissioner's room in the County Building. He thanked the staff and Jennifer Hanifan for everyone's help with this.

John Beck – Review of old contracts revealed a farm where the Cooperator has died and the property was sold in 5-acre plots. A lot of these have turned up

lately and we are requesting guidance from the Attorney General on how to handle.

Denny Norris asked how to make sure we are covered going forward with all the land transfers here. Part of this farm is still in existence.

John Beck stated that we will need more information before a discussion can take place.
